I. Scope of delivery

TELE-FONIKA Kable S.A. (Buyer), under the project: "Development of highly conductive, high strength, self-supporting and conducting cores for low-loss overhead power line conductors made of Cu-Ag alloys" co-financed by the National Centre for Research and Development (NCBiR), contract No CuBR/II/5/NCBR/2015, and KGHM Polska Miedź, contract No. KGHM-BZ-U-0654-2015 would like to invite you to submit your best offer for upgrade of Holton C300 conform machine to enable extrusion of aluminium layer on copper-silver alloy wire, including:

1. Parts for cladding aluminium on hard drawn copper-silver CuAg5 alloy wire including complete shoe assembly, coining roll assembly and mounting, scrapper assembly, extrusion wheel and other necessary tooling (dies, restrictors, supports, etc.) needed for cladding process described below:
2. Process conditions:
 - Aluminium feedstock for coating: aluminium wire rod of 9,5mm diameter, grade EN AW-1370 or EN AW-1350 temper H11 to EN 1715-2
 - Wire to be coated: Hard-drawn copper-silver CuAg5 alloy wire of diameter 4,0 +/- 0,5 mm, tensile strength > 1000 MPa,
 - Thickness of aluminium coating: 0,5 mm +/-0,1 mm
3. The scope of delivery shall include assist of Contractor engineers with assembly and setup of delivered parts on existing Holton C300 conform machine and initial production trials.

The line is situated in Cracow, 114 Wielicka Street.
